INDIA CONSULTANCY CHARGES - 1,00,000 INR + GST

Note:-

- 1) OTC fee is inclusive of Admission Letter, Invitation Letter, Documentation, Appostile, Translation, Airport Pickup, Registration Charges, 6 year Green Card/Visa Extension, etc.
- 2) Cost of Medical Insurance for all 6 years payable at once = 600 USD is not included in the package and the same have to be borne by the Student seperately.
- 3) Covid-19 Test in India & Ukraine, 7-14 days Quarantine Charges in Ukraine (if any) is not included in the Package and the same have to be borne by the Student seperately.
- 4) Minimum Cost of Hostel has been consider for the purpose of calculating the above Package. Renovated Hostel Charges = 200 \$ to 500 \$ is not included in the Package and the same have to be borne by the Student seperately if Student take renovated hostel.
- 5) Food Cost = 1200 USD per year additional to above Package & required to be paid as per the demand of the University. Food/Indian Mess is compulsory for 1st year.
- 6) Flight ticket is not included in the Package and the same have to be borne by the student seperately.
- 7) For the purpose of above mention calculation the rate of USD has been enumerated as 1 USD= 71 INR(approx)*
- 8) The student can pay tuition fee directly to the university.
- 9) Tutition fees & Hostel fee shall be in accordance to the website of the University.
- 10) Glen Education Link is only a Service Provider & shall not be liable for procuring any Confirmation of the Payment in respect to Hostel & Tutition fee from the University. The student shall be solely responsible for procurement of Receipts/Payments confirmation for any Deposites/Payments made to the University.
- 11) The student shall deposite Online or Carry the concerned Hostel & Tutition fee in USD on his Arrival in Ukraine.
- 12) Fee/Package mentioned in this pdf may vary from the Fee/Package provided on www.glenmbbs.com in such a event, The student is required to contact the Senior Admission Counselor of Glen Education Link.
- 13) The student is required to pay the OTC Fee/Charges in Ukraine.
- 14) For the purpose of availing the Services of Glen Education Link the Terms & Conditions mentioned on the website (www.glenmbbs.com) shall be applicable to every student.
- 15) Every amount provided in the Package are only indicative & approximate and the same may vary. Including but not limited Tutition fee, Hostel fee, OTC fee, India Consultancy Charges are variable in nature. The Hostel fee, Tutition fee provided on the website of the concerned University shall be treated as final and all payment thereof shall be made by Student in accordance to the same.
- 16) OTC(one time charges) is for 1st year only.
- 17) DSMU has the right to change the tutition fee no more than once a year, no more than the officially determined inflation rate in Ukraine for the previous calander year with obligatorily informing the student about the change.
- 18) *Rate of US Dollar shall be applicable as per the reference rate of Reserve Bank of India on the Date of Payment.
